## October 2021 Highlights and FFTC Investment Pool Performance

Global equity markets rebounded in October after September's sharp decline. Investor concerns over inflation and economic growth were offset by strong earnings reports from companies reporting third quarter results. As measured by the MSCI ACWI, global equity markets were up 5.1% in October and nearly 16.0% YTD. In the U.S., the S&P 500 was up 7.0%, bringing the YTD returns to 24%. In October, all S&P 500 sectors were positive, with all but three sectors showing returns above 5%. The U.S. markets outperformed Non-U.S. markets due primarily to its higher exposure to growth stocks.

The yield on the 10-year U.S. Treasury remained largely unchanged for the month. However, the yield on 10-year Treasury Inflation Protection Securities (TIPS) rose to 2.51% in October, it's highest since trading began in 1990 but in line with the Federal Reserve's long-term inflation target of 2.5%.
